## **MedLife Medical System acquires the first laboratory of pathological anatomy, Onco Team Diagnostic**

Onco Team Diagnostic Laboratory, located in Bucharest and with over 6 years of activity on the market, is one of the reference laboratories for this segment, providing patients with a fully automatic system of pathology, immunohistochemistry and molecular biology. The medical team, made up of doctors with more than 20 years' experience, ensures a diagnosis of maximum accuracy, using leading methodologies and techniques in the field.

As a consequence, the laboratory covers a wide range of tests from the histopathology and immunohistochemistry segments, as well as cytodiagnostic examinations.

At the same time, it is also a great opportunity to develop our business, thus benefiting from all the strategy and support of the group in the medical and management areas. According to company representatives, in 2018 the unit registered a turnover of 1.1 million euros.
