

*Technical specifications regarding changing the symbol for the shares of the issuer
CHIMCOMPLEX BORZESTI SA ONESTI from CHOB in CRC,
taking into account the admission to trading on the regulated market of the issuer's shares*

As a result of the information provided by the issuer CHIMCOMPLEX BORZESTI SA ONESTI regarding changing of the trading symbol for its shares from **CHOB** in **CRC** and taking into account the transfer of its shares from MTS to the regulated market, the following operations will be carried out in the BVB's trading system, so that the symbol CRC will be utilised starting with **January 17, 2022**:

- the symbol **CHOB** will be suspended from trading on **January 13-14, 2022**, based on those indicated by Depozitarul Central;
- after closing of the last trading session for the symbol **CHOB** (**January 12, 2022**), all existing orders placed in the Arena trading system on the symbol **CHOB** will be removed;
- the symbol **CRC** (that will have the symbol's type: *SHARE*) will be traded starting with **January 17, 2022** in the markets REGS and DEALS, with the application of the maximum price variation of +/-15% compared with the reference price;
- the reference price for the new symbol, **CRC**, valid for the trading session from **January 17, 2022**, will be the closing price of the symbol **CHOB** from its last trading session; the other features of the symbol **CRC**, except those specified, will be the same as for the symbol **CHOB** (liquidity band, minimum deal value, etc.);
- starting with **January 17, 2022**, the trading of the issuer's shares will be carried out exclusively on the symbol **CRC**;
- on **January 17, 2022**, the Pre-open stage of the symbol **CRC** in the main market (codified: REGS) will start at **9:30**, for entering/ managing orders by the BVB Participants. The schedule for the other trading session stages for the respective symbol will remain unchanged;
- the **CHOB** symbol will be delisted and all the historical data will be available on this symbol.

The information related to the displaying on the BVB's webpage:

- Starting with **January 17, 2022**, the information about the shares of the issuer CHIMCOMPLEX BORZESTI SA ONESTI will be exclusively updated on the section of the **CRC** symbol from the BVB's webpage.

- Excepting the historical trading data and the historical information from the News panel, all the information prior to **January 17, 2022** available in the section of the **CHOB** symbol from the BVB's webpage will be taken over in the section of the **CRC** symbol from the BVB's webpage (including trading charts).
- An information note will be included in the section of the **CRC** symbol from the BVB's webpage, according to which „for the days prior to **January 17, 2022**, the section of the **CHOB** symbol from the BVB's webpage will be accessed.”
 - we mention that all the information corresponding to this issuer available on the BVB's webpage prior to this date will be kept in the section of the **CHOB** symbol.
