Decisions of the Indices Committee in the meeting of September 5, 2024

Bucharest Stock Exchange (BVB) informs that on September 5, 2024 took place the quarterly meeting of the BVB Indices Committee ("IC"). BVB Indices Committee has decided the following:

- 1. To change the composition of BET, BET-TR and BET-TRN indices, as follows;
 - 1.1 Inclusion: PREMIER ENERGY (PE); ANTIBIOTICE (ATB);
 - 1.2 Exclusion: CONPET (COTE); BURSA DE VALORI BUCURESTI (BVB);
- 2. To change the composition of BET-XT, BET-XT-TR and BET-XT-TRN indices, as follows:
 - 2.1 Inclusion: PREMIER ENERGY (PE);
 - 2.2 Exclusion: ROMCARBON (ROCE);

- 9. Approval of the calculation date and the date of entry into force of the new structures, factors, and weights for the BVB indices.

The weights of the indices' components, the free-float factors (FFi), the representation factors (FRi), the liquidity factors (FLi) and the price correction factors (FCi) will be determined based on the number of shares and closing prices registered at the end of the trading session of **September 6, 2024**.

The new structures of BVB indices will be announced at the end of **September 6, 2024** and will become effective starting **September 23, 2024.**
