## Millenium Insurance Broker shares will start trading on the Multilateral Trading System of the Bucharest Stock Exchange on February 27

Bucharest Stock Exchange (BVB) informs that on Monday, February 27, will start trading the [Millenium Insurance Broker \(MIB\) Broker de Asigurare - Reasigurare S.A.](#) shares on the AeRO market, the equity segment of the Multilateral Trading System of the Stock Exchange. The company's shares will be available under the stock ticker [MIB](#). Millenium Insurance Broker (MIB) Broker de Asigurare - Reasigurare S.A., founded in 1997, has been providing complete services and solutions in the insurance field for over 25 years, being also the first insurance broker in Romania to develop, since 2008, a territorial network in the franchise system. The broker is present in 79 localities in 35 counties through a network of 130 franchises.

The company's shares will be traded under the stock symbol MIB following the private placement held between October 13-25, 2022, after which Millenium Insurance Broker attracted RON 4.2 mn. Through the capital increase operation, the company issued and sold to 42 investors, of which 32 legal entities and 10 retail investors, 347,587 new ordinary shares. As part of the private placement, a number of 601,295 ordinary shares were subscribed with a nominal value of 0.28 lei/share. The subscription price in the offer was 12 lei/share. The anticipated capitalization of the company is RON 25,026,240. The financial sources will be used to attract smaller brokers, digitize the activity, and promote new insurance products. The private placement and the listing were made with the [BRK Financial Group](#)'s support.

The Millenium Insurance Broker team will ring the bell of the Bucharest Stock Exchange on the February 27 to mark the entry into trading of the company's shares. The event will be broadcast LIVE, from 09.40 AM, on BVB's social media channels [Facebook](#), [YouTube](#), and [LinkedIn](#).
