on the availability of the 2025 Report
AUDITED VERSION

The management of **CHROMOSOME DYNAMICS S.A.** informs investors that the 2025 Annual Report, prepared in accordance with the provisions of Law no. 24/2017 (republished) and ASF Regulation no. 5/2018, as subsequently amended and supplemented, initially published on 21.04.2026 in unaudited form, has been updated following the completion of the financial audit process and will be made available to the public on 24.04.2026, starting at 18:05, on the Bucharest Stock Exchange (BVB) website, as well as in physical format at the company's registered office in **Bucharest, Sector 6, Bulevardul Iuliu Maniu, no. 7, Building A, Office A23, 2nd Floor**, and on the company's website <https://www.chrd.ro>, in the Investors section (CHR D): <https://www.chrd.ro/blog>.

Following the completion of the financial audit, the financial statements have been updated to reflect a series of adjustments and reclassifications in the financial statements and explanatory notes, the main changes being as follows:

1. Reclassification of amounts from account #267 from financial investments to receivables, impacting form F10 (row 03 – now 0 and row 06 – updated to RON 2,055,110) and form F40 (row 19 – now 0);
2. Update of receivables by including amounts related to accounts #267, #4382, #4551 and #542;
3. Revision of short-term and long-term liabilities (F10, row 15 – RON 3,186,515 and row 18 – RON 1,505,429), reflecting the correct recognition of lease and loan obligations (account #462);
4. Adjustment of the revenue structure in form F20 (row 02), reflecting predominantly revenues from account #701 (RON 5,548,632);
5. Corrections in form F30, including:
 - Update of the number of employees and related indicators (rows 20 and 21);

- Alignment of liabilities according to maturity schedule (rows 37, 39 and 71 – RON 836,950);
 - Reclassifications between positions (including rows 48–49 and 79);
 - Update of amounts related to affiliated entities and management personnel (row 79 – RON 71,795);
 - Update of amounts related to external suppliers (row 124 – RON 140,030);
 - Alignment of data with information provided by the Central Depository (rows 170/171 – individuals 155,586 and legal entities 3,078);
6. Corresponding updates in the explanatory notes to the financial statements, in line with the above changes.

As a result of these changes, the 2025 Annual Report is now audited and reflects the final version of the company's financial statements.
