**Important events to be reported:** Notice regarding the payment of Coupon No. 9 for the bonds issued by IMPETUM INVESTMENTS S.A., maturing on 30 June 2026

IMPETUM INVESTMENTS S.A. (the “Company”) hereby informs investors regarding the payment of Coupon No. 9 related to the corporate bonds issued by the Company on 20 June 2024 and traded on the Multilateral Trading System operated by the Bucharest Stock Exchange (BVB) under the symbol IMPI27E. The coupon payment will be made on 30 June 2026, in accordance with the provisions of the Listing Memorandum.

The payment of Coupon No. 9, with a gross value of EUR 22.4384 per bond, will be carried out through Depozitarul Central S.A. to the bondholders registered in the Bondholders’ Register maintained by Depozitarul Central S.A. as of the record date, 16 June 2026.

The amounts due will be paid by bank transfer to the accounts of the participants in the Depozitarul Central settlement system.

IMPETUM INVESTMENTS S.A. will collect tax residency certificates until 19 June 2026. For non-resident individual bondholders who do not provide a valid tax residency certificate, withholding tax will be applied at source on the amounts due, in accordance with the provisions of the Romanian Fiscal Code currently in force, Article 224 paragraph (4).

According to the provisions of the Listing Memorandum, the coupon amount for the 91-day period from 31 March 2026 to 30 June 2026 (inclusive) has been calculated based on a fixed annual interest rate of 9%.
