

Meta Estate Trust advances the transition towards recurring income-generating assets and prepares for listing on the Main Market

Bucharest, March 30, 2026 – Meta Estate Trust (stock symbol MET), a holding company active in the real estate sector and capital markets, advances the transition towards an investment model focused on recurring income-generating assets and a positioning oriented towards institutional capital, in the context of preparing for listing on the Main Market of the Bucharest Stock Exchange.

The Company aims to increase the share of recurring income-generating assets within its portfolio, alongside the gradual monetization of investments from the Trading segment and the reallocation of capital. 
This strategic direction is implemented under the leadership of Dan Petrișor, who assumed the role of CEO at the beginning of 2026, with a mandate to accelerate the maturation of the investment model and prepare the Company for access to institutional capital.

Dan Petrișor, CEO of Meta Estate Trust:

“2025 was a year of transition and consolidation for Meta Estate Trust, and in the period ahead we are focused on executing a strategy aimed at delivering sustainable long-term value for shareholders. We are building a disciplined investment model, shifting the focus towards recurring income-generating assets and a more balanced portfolio structure. Our priorities are centered on growth, predictability, and transparency, alongside strengthening our relationship with investors and partners. At the same time, 2026 is a year of recalibration, during which we are simplifying the portfolio, monetizing exposures that are no longer aligned with our strategic direction, and reallocating capital toward opportunities with greater visibility and predictable cash flows. Our objective is to consolidate a coherent investment portfolio, built on a scalable business model capable of delivering long-term value and supporting access to institutional capital.”

The financial results for 2025 confirm the Company's growth trajectory and support its strategic consolidation. Meta Estate Trust reported total assets of RON 135 million (+11% vs. 2024), an investment portfolio of RON 119.3 million (+9% vs. 2024), and a turnover of RON 15.3 million (+11% vs. 2024). Total revenues amounted to RON 32.4 million, while gross profit reached RON 11.5 million, alongside a positive fair value result from the revaluation of real estate investments of RON 1.1 million.

The transition process to the regulated market of the Bucharest Stock Exchange is underway, with completion targeted for mid-2026, subject to the completion of the applicable approval steps.
