Important events to be reported: 2024 Revenue and Expense budget estimate

The management of Simtel Team S.A. (the "Company") informs the market about the availability of the 2024 Consolidated Revenue and Expense Budget. The Revenue and Expense Budget outlined below will be subject to approval at the annual Ordinary General Meeting of Shareholders, which will take place on April 25, 2024.

In 2024, the Company's management aims to significantly accelerate the total installed capacity from 2023 of 86 MWp, thanks to the photovoltaic power plants that will be built for clients, as well as based on the contribution of the Company's own photovoltaic parks, considering that some of these are already at the ready-to-build stage and are set to enter the implementation phase.

Furthermore, the growth potential in the renewable energy sector remains high, considering the need for companies across all industries in Romania to transition to green energy. Additionally, several governmental initiatives in Romania support such investments as the National Recovery and Resilience Plan (PNRR), projects within the Rural Investment Financing Agency (AFIR), the Modernization Fund, and Electric Up 2. Considering these aspects, in 2024, the Company intends to capitalize on all the existing opportunities to continue the development of the Simtel group and consolidate its market-leading position in this field.
