Important event to be reported: *Application for summons filed by a shareholder*

OIL TERMINAL S.A. informs shareholders regarding the fact that on 27.09.2021 the application for summons, filed by complainant Dumitrescu Andrei Sebastian, was received at the company's headquarters, against Oil Terminal S.A., the Romanian State through the Ministry of Energy and the Romanian State through the Ministry of Public Finance requesting Constanta Court to pronounce a decision in this regard:

1. *Declaration of the fact that all the tanks object of GEO no. 15/2001, approved by Law no. 68/2002 is in the private property of the company Oil Terminal S.A., heads of claim evaluated at the amount of 27,684,210.15 lei.*
2. *Mainly, to force the defendant Romanian State by the Ministry of Public Finance to leave in full ownership the buildings mentioned in point 1 to the defendant Oil Terminal S.A., heads of claim evaluated at the amount of 27,684,210.15 lei.*
3. *As a further alternative, to force the defendant Oil Terminal S.A. to immediately promote a claim action having as object the buildings mentioned in point 1, heads of claim evaluated at the amount of 27,684,210, 15 lei.*
4. *To force the defendants jointly and severally to pay the court costs incurred in the present case.*

The litigation does not yet have a trial term, the file is in settlement procedure.

We specify that by Emergency Ordinance no. 15/2001 regarding the regulation of the legal situation of tanks, oil and petroleum products transport pipelines, pumping stations and

other related installations and equipment, Oil Terminal S.A. was declared a company of strategic interest, and "the tanks, oil and petroleum products transport pipelines, pumping stations, other related installations and equipment, which were transferred to the patrimony of the Commercial Company "Oil Terminal " - S.A. Constanta by the Government Decision no. 200/1990 regarding the establishment of joint stock companies in industry, with further alterations, are and remain in the public property of the state and are part of the public domain of national interest".

Oil Terminal S.A. will proceed to perform all the procedural steps required in this case.
