• Net result: 25 million lei

• Assets under management: 2.156 billion lei

• Net asset value per share: 2.0656 lei

Please find attached the EVERGENT Investments Assets and Liabilities Statement as of February 2021, in compliance with FSA Regulation 9/2014 - Annex 16 - along with a brief analysis of the main variations registered in the value and structure of the assets under management.

Main evolutions by asset categories:

- listed shares: 55.7 million lei;
- non-UCITS listed shares: 0.5 million lei;
- unlisted shares: 5.8 million lei;
- corporate bonds: + 0.1 million lei;
- fund units: + 9.3 million lei;
- monetary instruments: + 7.9 million lei.

The weight of the main categories of assets in the total value of the assets under management: listed shares including the non-UCITS listed shares 68.4%, unlisted shares 9.5%, fund units 14.2%, monetary instruments 6.3%.

The net result, in the amount of 25 million lei, consists of 12.8 million lei net profit and 12.2 million lei net gain from the sale of assets reflected in the retained earnings - accounting treatment in accordance with IFRS 9.
