TTS informs shareholders and investors on the publication of the **”TTS November 2023 Trading Bulletin – Liquidity and Market Capitalization”**.

**November 2023, in brief:**

- In November 2023 TTS shares **ranked among the top ten** most traded stocks in terms of total value of recorded transactions and **passed the liquidity test** for inclusion in the FTSE Russel Global SmallCap Index **for the 6th consecutive month**.
- According to the ["Monthly Bulletin. NOVEMBER 2023"](#) published by the BVB, **TTS shares ranked 10th** in the list of the most traded shares on the BVB, with a transaction value of 31,752,858 RON (6,922,582 USD), representing **2.8%** of the total value of transactions registered of the actions included in the Premium Category. Among the stocks included in BET, **TTS was surpassed in the ranking only by stocks with a capitalization of at least two times higher:** FP, H2O, TLV, SNP, SNG, EL and BRD
- The median value of the daily volume of TTS shares traded in November 2023 was 43,663 shares, 94.9% higher than the liquidity threshold required for inclusion in the FTSE Russell Global SmallCap Index, equal in the case of TTS to 22,408 shares, respectively 0.05% of free-float (44,815,680 shares).
- In November 2023 **1,329,657 TTS shares** were transacted (+**37.1%** Δ nov.2023 / oct.2023, +**139.5%** Δ nov.2023 / nov.2022), the daily average being of **63,317 shares** (+**43.7%** Δ nov.2023 / oct.2023, +**139.5%** Δ nov.2023 / nov.2022).
- The total value transacted was **31,752,858 RON** (+**52.5%** Δ nov.2023 / oct.2023, +**420.4%** Δ nov.2023 / nov.2022), the daily average being **1,512,041 RON** (+**59.8%** Δ nov.2023 / oct.2023, +**420.4%** Δ nov.2023 / nov.2022).




