Preliminary financial results for the period January – December 2023

CONPET SA registered, in 2023, a turnover of 485.11 million RON, higher by 2.7% YoY.

On 31 December 2023, the operating revenues recorded an increase by 3.6%, compared to the similar period in 2022 (540.76 million RON: 12 months 2023 from 522.06 million RON: 12 months 2022).

The operating expenses recorded an increase by 3.7% compared to the similar period in 2022 (12 months 2023: 476.41 million RON, 12 months 2022: 459.29 million RON). The increase in the operating expenses was mainly determined by the increase of the expenses with the modernization quota, by the crude oil royalties, by the personnel expenses and by the depreciation and rail transportation expenses.

The operating profit achieved in 2023, of 64.35 million RON, increased by 1.58 million RON, compared to 2022. Compared to the Budget, the Operating Profit increased by 21.2%.

In 2023, the company recorded a net profit of 60.24 million RON, less than the same period of 2022 by 1.43 million RON, but over the budgeted level by 12.30 million RON.
