**regarding the results recorded by Infinity Capital Investments S.A.  
as of 30.06.2024**

In the first 6 months of 2024, the net asset of Infinity Capital Investments S.A. continued to have an upward trend, registering on 30.06.2024 the historical maximum, respectively the value of 3,633,261,130 lei. On 30.06.2024 the unit value of the net asset is 7.6790 lei/share.

The net profit of the reporting period is 104,695,482 lei, a significant increase of 467.87% compared to the net profit of 18,434,626 lei recorded in the similar period of the previous year, this indicator being influenced by the dynamics of dividend income.

The Company's assets on 30.06.2024 show a value of 3,905,262,984 lei, registering an increase of 30.15% compared to 31.12.2023 (3,000,661,604 lei).

The financial assets valued at fair value through other elements of the global result, in the amount of 3,698,670,448 lei, are increasing by 27.08% compared to 31.12.2023 (2,910,615,793 lei). This increase is mainly due to the appreciation of the value of the shares in the company's portfolio and which are listed on the capital market.

Equity, in the amount of 3,633,261,130 lei, registered an increase of 29.89% compared to 31.12.2023 (2,797,169,778 lei), being influenced, mainly, by the evolution of the indicator "*Reserves from the revaluation of financial assets at fair value through other elements of the overall result*".

We mention that the individual half-yearly financial statements on 30.06.2024 are not audited by the Company's external financial auditor.
