At the end of this stage, the program's independent jury decided which are the companies whose organizational and managerial practices









are best aligned with the international Best Managed Companies standard. Therefore, within the second edition of the Best Managed Companies Romania program, 17 companies were certified, including TeraPlast, and 4 companies were recertified.

The four pillars of assessment include strategy, resources and innovation, culture and engagement, as well as corporate governance and financial aspects of the company.

The uniqueness of this programme lies in its focus on private companies in Romania, acknowledging their overall performance and supporting long-term growth, as it appreciates organizational efforts beyond the financial achievements.
