- The median daily volume of TTS shares traded in December 2023 was 37,374 shares (-14.4% Δ Dec-23 / Nov-23, +235.4% Δ Dec-23 / Dec-22), with 66.8% higher than the liquidity threshold required for inclusion in the FTSE Russel Global SmallCap Index, which is equal to 22,408 shares, representing 0.05% of the free float (44,815,680 shares).






