



## SUMMARY OF THE Q3 2025 FINANCIAL REPORT

In the **third quarter of 2025**, Transilvania Broker de Asigurare S.A. maintained its growth momentum, with the value of insurance policies brokered exceeding RON 250 million, up 9% compared to Q3 2024. The same growth rate was recorded for the first nine months of the financial year, during which the Transilvania Broker team brokered insurance policies worth over RON 777 million.

The lifting of the cap on insurance premiums and distribution commissions led to **revenues of RON 31.8 million in Q3 2025**, representing **an increase of more than 26% year-on-year**, while aggregate **revenues for the reporting period (January 1 - September 30, 2025) reached approximately RON 87 million, up 10.8% compared to September 30, 2024.**

Investments in accelerating the implementation of the Company's growth strategy resulted in higher expenses for key human resources involved in the integration of new business divisions, as well as for the digital infrastructure required to support them. Consequently, operating expenses increased by 12.6%, leading to a decline in the operating result.

As of September 30, 2025, the reported net profit amounted to **RON 1,148,210**. The Company's short-, medium-, and long-term financial stability indicators remain within a comfortable and balanced range, confirming the soundness of Transilvania Broker's financial position.
