

At the hearing held on 31 March 2026, the Court ruled as follows: "Brief ruling: The appeal is dismissed as unfounded. The appellant is ordered to pay the respondent legal costs in the amount of RON 113,464.27, representing attorney's fees, and the amount of RON 3,609.18, representing court stamp duty. Subject to recourse within 30 days from service of the decision; the recourse application shall be filed with the 6th Civil Division of the Bucharest Tribunal. Pronounced by making the ruling available to the parties through the registry of the court today, 31 March 2026."	-



2	3278/62/2020	Sanosan Pharmaceuticals S.R.L.- Debtor Biofarm – Creditor	Brasov Court of Law	Merits	Insolvency proceedings	Biofarm S.A. requested the opening of the insolvency procedure against the debtor Sanosan Pharmaceuticals, in the file 1484/62/2020, asking for the registration in the table of creditors with the amount of 8,066,750.88 lei (main debit and delay penalties). As the debtor also filed for insolvency, the court ordered the connection of the file 1484/62/2020 to the main application (considering Biofarm's application as a declaration of registration as a creditor), which forms the object of the file 3278/62/2020 on the role of Brasov Court of Law.	At the hearing held on 26 March 2026, the Court decided as follows: "Having regard to the contents of the report drawn up by the judicial liquidator pursuant to Article 59 para. (3) of Law No. 85/2014, it sets an administrative review date for 10 September 2026, in Chambers, without the presence of the parties, for the purpose of continuing the liquidation procedure, settling the disputes involving the debtor, and recovering claims against its own debtors."	10.09.2026
