Main monthly relevant evolutions by asset categories (in RON):

- listed shares: + 7.8 million
- AIF listed shares: + 0.7 million
- fund units: + 6.1 million
- monetary instruments: - 8.8 million

The main asset classes in the total value of the assets under management: listed shares including the AIF listed shares 67.7%, unlisted shares 9.2%, fund units 11.8%, monetary instruments 10.4%.

The net result, amounting to RON 207.62 million, consists of RON 53.50 million net profit and RON 154.12 million net gain on the sale of financial assets reflected in retained earnings - accounting treatment in accordance with IFRS 9.
