- monetary instruments: + 0.02 million

The main asset classes in the total value of the assets under management: listed shares including the AIF listed shares 69.9%, unlisted shares 8.0%, fund units 11.9%, monetary instruments 9.5%.

The net result, amounting to RON 473.99 million, consists of RON 267.01 million net profit and RON 206.98 million net gain on the sale of financial assets reflected in retained earnings - accounting treatment in accordance with IFRS 9.
