

**PRESS RELEASE**
**regarding the results recorded by Infinity Capital Investments S.A.**
**as at 31 March 2026**

In the first three months of 2026, the net asset value of Infinity Capital Investments S.A. amounted to RON 4,551,811,602, representing an increase of 4.14% compared to the value recorded as at 31 December 2025 (RON 4,370,783,187). The corresponding net asset value per share was RON 12.7147 per share. The closing price on 31 March 2026 (the last trading session of Q1 2026) for one INFINITY share was RON 3.92 per share, up 5.95% compared to the closing price at the end of 2025 (RON 3.70 per share).

As at 31 March 2026, the Company recorded a net loss of RON 1,804,773 (Q1 2025: RON 1,221,690), in the context where the Company's revenues are derived principally from dividends received from portfolio issuers, and no dividends were distributed during the first quarter of 2026.

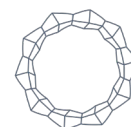
As at 31 March 2026, the Company's total assets amounted to RON 5,007,577,097, representing an increase of 5.03% compared to 31 December 2025 (RON 4,767,844,952).

Financial assets measured at fair value through other comprehensive income, amounting to RON 4,741,635,037, increased by 7.97% compared to 31 December 2025 (RON 4,391,740,695). This increase is attributable to capital market performance during Q1 2026.

Equity, amounting to RON 4,551,811,602, increased by 4.14% compared to 31 December 2025 (RON 4,370,783,187), influenced primarily by movements in the Reserves from the revaluation of financial assets at fair value through other comprehensive income.

The Interim Simplified Individual Financial Statements as at 31 March 2026 have not been audited by the Company's external financial auditor.
