Societatea Nationala Nuclearelectrica S.A. (“SNN”) informs its shareholders and investors that, SNN placed with Exim Banca Romaneasca a term deposit without extension in the amount of 100.000.000,00 lei, on 09.03.2026.

The percentage interest rate that applies to the above-mentioned term deposits is of 6.30 % /year. The maturity date is on 12.10.2026.

We specify the fact that on 09.03.2026, SNN has deposits with Exim Banca Romaneasca, in the cumulative amount of 948,200,000.00 lei (Annex no. 1), which exceeds 10% of the net turnover for the last annual financial statements.
