[Bucharest Stock Exchange \(BVB\)](#) announces that the process of shortlisting 50 companies that will enter the last stage of *Made in Romania* project has ended. 25 companies were selected through the votes casted by the Nomination Committee Members while the additional 25 were chosen by the Bucharest Stock Exchange representatives.

"The competition was fierce and the selection of 50 out of 166 companies was difficult. We are proud to have seen that many great Romanian companies applied to this Bucharest Stock Exchange's project. The companies will then participate in a special mentorship program which will run between April and November 2017. Every month between April and November 2017 will have a different theme, such as marketing and branding, strategy and innovation, audit or financing for growth. Based on the theme of the particular month, a number of top-quality workshops, trainings and 1-to-1 meetings will be organized for the companies' dedicated teams/employees. Through such organization, within the 8 months BVB together with the partners will have a chance at inciting innovation and best practices at the selected companies and thus supporting their growth. The project is offered to the companies free of charge and is voluntary.
