Romania's weight in the MSCI Frontier IMI indices increases – two new companies listed on the Bucharest Stock Exchange will be included in the indices

- **Nuclearelectrica's shares will be included, starting with 1st of June 2023 in the MSCI Frontier Markets and MSCI Romania indices**
- **One United Properties' shares will be included started with the same date in the MSCI Frontier Markets Small Cap and MSCI Romania Small Cap indices**
- **Other 9 companies listed on the Bucharest Stock Exchange are already included in the MSCI Frontier IMI (Investable Market Index) indices: Banca Transilvania, BRD Groupe Societe Generale, Electrica, Medlife, OMV Petrom, S.N.G.N. Romgaz, Teraplast, Transelectrica and Transgaz**
- **Therefore, Romania will have starting with the 1st of June, 11 listed companies in the MSCI indices dedicated to frontier markets**

The shares of the companies [Societatea Națională Nuclearelectrică \(SNN\)](#), the sole producer of nuclear power and nuclear fuel using CANDU 6 type technology in Romania and [One United Properties \(ONE\)](#), one of the leading green developers of residential, mixed use and office real estate, in Romania will be included starting with 1st of June 2023 in the MSCI Frontier IMI indices according to the announcement made public by MSCI on May 11, 2023. The two new companies will increase Romania's weight in the MSCI Frontier IMI indices to 11 companies, alongside Banca Transilvania, BRD Groupe Societe Generale, Electrica, Medlife, OMV Petrom, S.N.G.N. Romgaz, Teraplast, Transelectrica și Transgaz.

The shares of SNN, company listed on the Main Market of the Bucharest Stock Exchange since November 4, 2013, will be included starting with the 1st of June 2023 in the MSCI Frontier Markets and MSCI Romania indices. SNN is one of the first two companies included in the indices FTSE Global All Cap, when Romania was promoted to the Emerging Market status by the global index provider FTSE Russel, in 2020. The company's shares are also included in BET, the main

index of BVB and also in the indices: BET-TR, BET-TRN, BET-XT, BET-XT-TR, BET-XT-TRN, BET-BK, BETPlus, BET-NG, and ROTX. At the end of May 30, 2023, the company's market cap was RON 15.5 bn.

ONE is one of the leading green developers of residential, mixed use and office real estate, in Romania, listed on the Main Market of the Bucharest Stock Exchange since July 12, 2021. The company's shares will be included in the MSCI Frontier Markets Small Cap and MSCI Romania Small Cap starting with June 1, 2023. ONE's shares are also included in the FTSE Global All Cap indices, dedicated to Emerging Markets as of November 22, 2021. One United Properties is included, as well, in BET, the primary index of the Romanian market and in BET-TR, BET-TRN, BET-XT, BET-XT-TR, BET-XT-TRN, BET-BK, BETPlus, and ROTX. The capitalization of the company on May 30, 2023, was RON 3,55 bn.

MSCI is one of the leaders in providing global indices benchmarks. Currently, Romania is classified by MSCI as a Frontier Market. The listing on the stock exchange of Hidroelectrica - a leader in electricity production and the main provider of technological services needed in the National Energy System, will increase the opportunity for Romania to be promoted by MSCI to the Emerging Market status.
