Multiple records at the BVB in 2023: market value of all listed companies of over RON 300 billion, total transactions of RON 38 billion and indices at historical highs

- In 2023, the Bucharest Stock Exchange hosted the largest initial public offering (IPO) in Europe: RON 9.3 billion (EUR 1.8 billion) through the listing of 20% of Hidroelectrica.
- The total trading value recorded in 2023 across all markets, encompassing all types of financial instruments, exceeded RON 38 billion, marking a 58% increase compared to the previous year.
- The average daily liquidity across all types of instruments listed on the Regulated Market (RM) and on the Multilateral Trading System (MTS) reached RON 153 million. This result represents a 60% increase compared to 2022, highlighting investors' confidence in the efficiency and transparency of the capital market.
- The share price of the Bucharest Stock Exchange (BVB) increased by 86% in 2023, reaching RON 65.6 per share, corresponding to a market capitalization of RON 528 million (EUR 106.2 million). Throughout 2023, BVB shares were traded between a low of RON 35.6 (January 3, 2023) and a high of RON 73 (November 17–19, 2023).
- The BET index, which includes the 20 most liquid companies listed on the Main Market, increased by 32%, while the BET-TR index climbed by 40%. The BET-TR index had the best performance in the region in 2023.
- A record amount of 5.5 EUR billion was raised through 34 listings of stocks and bonds.
- The number of investors reached over 168,000 by the end of September, marking a historic record and a growth of 40,000 investors compared to September 2022. Over the past nearly four years, the number of investors has tripled, rising from nearly 54,000 at the end of 2019.

The year 2023 was a chapter of unprecedented performance for the Romanian capital market, recording historical highs on several levels, such as the value of stock and bond transactions, average daily liquidity, stock market indices, market value of companies.

A key highlight of 2023 was the successful completion of the largest stock listing in Europe, namely that of Hidroelectrica, amounting to RON 9.3 billion (EUR 1.8 billion). This listing strengthened the BVB's position in the European financial landscape and generated a significant wave of interest and confidence in the Romanian capital market.

At the end of 2023, the main BET index reached 15,371 points, reflecting a 31.79% increase over the previous year. This significant advance underlines the excellent performance of the 20 most traded stocks listed on the Stock Exchange. In a landmark moment, on 8 December, the main index surpassed the 15,000-point threshold for the first time in history.

The BET-TR index ended the year at a level of 31,745 points, marking an increase of 39.93% since the last trading day of the previous year. This performance reflects not only the evolution of share prices, but also the total impact of dividends paid by the index's component companies.

Another significant achievement in 2023 was the surpassing of the liquidity record set in 2022. The total value of transactions across all markets and for all types of financial instruments exceeded RON 38 billion, marking a notable 58% increase from the previous year.

The number of 1.977 million transactions made by investors in all markets in 2023 represents a level unprecedented since 2007. In particular, the number of share transactions on the Main Market reached 1.46 million transactions, demonstrating the active interest of investors.

Two companies were listed in 2023 on the Bucharest Stock Exchange following successful listing offers: Hidroelectrica on the Main Market and Millenium Insurance Broker on AeRO.

In addition, through 11 corporate bond issues, issuers attracted €1.6 billion, highlighting the increased appetite for funding. The Ministry of Finance was also active in the capital market, attracting €1.9 billion through 20 Fidelis government bond issues.

News to investors

- The Ministry of Finance (MF) attracted RON 933.4 million and EUR 310 million respectively (values totalling RON 2.47 billion - EUR 497.7 million) through the fourteenth primary offering of government securities for the general public (FIDELIS) conducted in the last four years through the Bucharest Stock Exchange (BVB) systems. This is the third largest Fidelis offering by value since the resumption of these issues on the BVB in July 2020. Further details are available [here](#).
- UniCredit Bank, part of the UniCredit Group and one of Romania's leading banks, has listed its second corporate bond issue of 2023 on the stock exchange, worth RON 480 million. The bonds are traded on the Regulated Market of the Bucharest Stock Exchange, under the stock symbol UCB28. The senior unsecured corporate bonds have a nominal value of RON 500,000 and a fixed interest rate of 7.82% per annum. The maturity date is 24 November 2028. The issue of UniCredit Bank's corporate bonds in lei is part of a wider programme to diversify funding sources, aimed at increasing access to finance for the bank's clients. - Banca Comercială Română (BCR) has listed a new bond issue worth 1 billion lei, BCR29 is the 10th bond issue listed by the bank on the stock exchange in the last 4 years, the value of all these issues reaching 8.8 billion lei. The issue consists of senior non-convertible bonds with a maturity of 6 years. The bonds received a long-term rating of BBB+ from Fitch and Baa2 from Moody's. BCR has issued 2,000 shares with a nominal value of RON 500,000 and a fixed interest rate of 7.55%. Further details are available [here](#).

METHODOLOGICAL NOTES

Section A. Main Indicators

1. *Financial instruments already issued / registered* – this category includes all the statistical data related to the existing financial instruments, regardless of the type of the operations carried out.

The total values traded as well as the average daily value for this category are based on:

- trading operations performed on regular, deal;
 - offers and operations performed with the existing financial instruments such as: buy offer, takeover offer, secondary offer for selling the existing financial instruments, other methods of selling the existing financial instruments, offers without prospectus or with simplified prospectus for currently issued financial instruments.
2. *New Issues and further issues* – this category contains the statistical data related to the issuance of new instruments based on the primary / initial offers as well as data regarding the increase of the capital for already listed companies, based on further issues. This category is related to the capital raised by the issuers.
 3. The total value traded is single counted.
 4. The total value traded expressed in EUR is calculated considering the daily EUR value, based on the currency rate available for each trading session.
 5. Equities includes shares and rights
 6. Bonds includes all types of bonds available for trading at BVB (municipal, corporate, government securities).

Section B. Specific Market Indicators

Trading value displayed in this section for a financial instrument includes the turnover registered in all market in which the respective financial instrument is traded.
